## AGREEMENT

1. This agreement is made between the Parents/Guardians (here in after called the "Guarantor" the expression shall unless be excluded by the context or the meaning thereof be deemed to include his heirs, executors, administrators, or legal representatives) of the one part and the Principal of the school of the second part.

Son/Daughter of ..... (hereinafter called the Student/Son/Daughter/Ward of the Guarantor) has, at the request of the Guarantor, been selected for admission to the Teacher Training College called the College.
3. Now, It is hereby agreed by the between the parties here to as follows :
  - (a) That in consideration of the student being admitted by the Principal to the college for the purpose of education at the request of the Guarantor, the Guarantor convenient with the Principal that the student shall attend the college regularly and shall observe and comply with all the rules and regulations thereof as prescribed and that the Guarantor shall pay to the principal regularly and promptly and whenever called upon to do so, all fee and other costs as prescribed.
  - (b) That the said student has been admitted on the understanding that his/her first year is probationary and that he/she shall be required to leave the college at the end of the first term of first year if the Principal is of he opinion that his/her capability and attainment does not reach the standard as specified and pre requisite for admission to the subsequent/standard.
  - (c) That the placing of students in different forms shall be at the sole direction of the Principal.
  - (d) That the principal shall at any time, in the interest of the college have the student removed if student fails to accept the discipline of the college and his/her continued presence is detrimental to the interest of other students and/or the student fails to come up to the academic standard of his/her course and detention in the same class would make the student too old for his/her class.
  - (e) That no fees, partial or full, shall be refunded if the said student to leave the college during the course of the term for any reason whatsoever.
  - (f) That the Principal shall not be liable for any damages/charges on account of injuries fatal or otherwise which may be sustained by the student, at any time during his/her stay in the college while taking part in studies, sports campus and extra curricular or any other form of activities of the college within or outside the college premises. All expenses that may be incurred in the treatment of such injuries shall be borne by the parent/guardian as provided in the rules of the college.
  - (g) That in case of any dispute to the effect or meaning of these present or in any way touching or arising out of these presents, the same shall be referred to the sole arbitration of the Principal, Shivam Teacher Training College, in Patna.
